Project Description/Justification:

Specific federally-funded programs:

Community Services Block Grants: As authorized by federal Public Law 97-35, throughout the United States the federal Department of Health and Human Services (H&HS) has designated 950 Community Action Agencies (CAAs) -- all of whom may then receive federal funding that passes-through the appropriate state agency. Within Alaska the federal H&HS has designated only one CAA -- that entity is the non-profit corporation Rural Alaska Community Action Program, referred to as RurAL CAP.

RurAL CAP's mission is to protect the heritage of, while also improving the quality of life for, low income rural Alaskans. This is accomplished through educational programs such as alcohol and drug abuse prevention programs, fetal alcohol syndrome prevention programs, and child development programs; adult training; affordable housing programs; advocacy for low-income individuals and instruction on how to advocate for themselves.

This program has been in existence since 1965. The federal Health and Human Services provides 100 percent of the funding. For FY2013, DCCED anticipates \$3,000.0 in federal funding.

Community Development Block Grants: This program provides grants not to exceed \$850.0 to municipalities for planning activities, infrastructure projects, and economic development activities which benefit low to moderate-income individuals.

This program has been in existence since 1983. The U.S. Department of Housing and Urban Development (HUD) provides the funding, which ranges from \$3,000.0 to \$3,500.0 annually with a state required match of 2%. For FY13, DCCED anticipates \$3,000.0 in federal funding with a state match of \$60.0.
