The district has experience chronic teacher turnover due to poor housing for teachers in the community. Under the status quo, teachers have sometime lived on boats and in the school office. The remodel will be minimal and include dividing a large space into several bedrooms. Even with a teacher just living in the office, fuel costs were crippling. Just running regular operating hours for the Port Alexander school can cost \$40,000.00 a year. By installing a battery back-up system for after hours, we estimate a savings of at least \$20,000.00 in the additional fuel costs per year of maintaining a teacher on the site.

Detailed Project Description and Justification:

Southeast Island School District requests funds for partial remodel of an attached school building with battery back-up installation to provide housing for teachers in the community of Port Alexander. Persistent teacher turnover connected to poor or expensive housing, when it can be found, puts the school's success in jeopardy.

Teachers have lived on boats and in the school office in the past due to lack of sufficient housing. The proposed remodel is modest and will include dividing a large space in an attached school building into several bedrooms. Running regular operating hours for the Port Alexander school can cost up to \$40,000 a year. By installing a battery back-up system in this attached building for heating after-hours, Southeast Island School District estimates a savings of at least \$20,000 in the additional fuel costs per year.

Construction labor will be done by existing School District staff with the exception of electrical work connected to the battery system and the housing unit.
