## **Detailed Project Description and Justification:**

Sidewalks in the downtown area of Palmer will be widened from four feet to five feet and ADA compliant curbs will be constructed at all intersections. In areas where sidewalks have heaved due to lack of proper bedding material, old existing sidewalks and improper bedding material will be removed and replaced. The surface of the new sidewalks will be a broom finish. Priority has been given to completing sidewalks in the core downtown area. Pedestrian safety will be significantly enhanced at downtown intersections.

By providing well-constructed ramps at intersections, overall quality of life will see improvements with increased mobility for residents with visual impairments and for anyone in scooters, walkers, wheelchairs, and other mobility aids. There are many senior facilities and housing accommodations in the Palmer area, and the benefits of better walking conditions will allow all residents more access to all areas of the walkable downtown.

A pedestrian-friendly environment is a key attraction and good for business. The City will be responsible for sidewalks connecting different areas of the community, with individual developers/subdividers taking responsibility for sidewalks and trails within subdivisions.

When the Palmer Comprehensive Plan was enacted in 2006, residents and members of the public identified maintenance and improvements to community trails and sidewalks as a very high priority.
