Detailed Project Description and Justification:

The Nenana City School District is requesting funds to address the condition of our electrical system. The NCPS was originally built in 1955 with additions in 1966, 1972, and 1986. The facility at that time was not built to withstand all the needs that we have today for computers, and other electronically operated devices. Most of our classrooms have a limited amount of outlets to use for their daily needs; therefore in order to achieve a classroom that is functional for this time period, we have had to use numerous amounts of extension cords and power strips which cause multiple hazards. It is a dangerous hazard for the facility as well as out of compliance with the insurance company, fire Marshall and OSHA. There are numerous tripping and fire hazards throughout the facility. It is our desire to make our facility safe for our students, staff and to the general population. The NCPS proposes to necessitate, reforming multiple electrical outlets throughout the school facility as well as reform junction boxes, wiring molding, receptacles, rewiring, and breaker panel upgrades. 
