The project will construct one Public Safety Building in each of three villages that are in dire need for adequate office and holding cells which include Platinum, Russian Mission and Lower Kalskag.

The AVCP region consists of 47 villages and most lack Public Safety Buildings. Other than the state supported Village Public Safety Officer program, law enforcement in rural areas may also include Village Police Officers and Tribal Police Officers. Public Safety Officers in the villages are the first responders to public safety emergencies such as basic law enforcement, search and rescue coordination, fire protection and prevention, emergency medical services, water safety, community policing, public safety education, disaster coordination, and probation and parole monitoring.

These officers have a significant impact for improved safety and quality of life in participating villages. Working with Alaska State Troopers, they stabilize most volatile conditions and protect crime scenes until help arrives. They complete misdemeanor and minor felony investigations with assistance by the Alaska State Troopers. Many of the Public Safety programs share offices with a community building, or a tribal council office, health clinic, head start office, or a fire station as a public safety site, with some having no holding cells.


