Funding Details:

Alaska Mental Health Trust Authority provides \$25,000/year in in-kind to the Alaska Brain Injury Network to support an anti-stigma campaign and treatment works campaign. This request would focus on prevention, identification and available resources.

Detailed Project Description and Justification:**Project Description**

This request is for capital costs associated with a five year statewide campaign for brain injury awareness, resources, and prevention. The operations costs will be covered by the Alaska Brain Injury Network. The purpose of the traumatic brain injury awareness campaign is to increase the public's awareness of the prevalence of traumatic brain injury, causes, prevention strategies and safety equipment, and information about resources. The awareness campaign will use public media (radio, television, newspaper, etc) as a mechanism for disseminating information. The Alaska Brain Injury Network will also work with tribal partners to disseminate information in the formats that work best for rural Alaska (posters, flyers, etc). ABIN would also like to work with youth and other organizations to support events that promote traumatic brain injury awareness activities.

Project Justification

The Alaska Trauma Registry shows nearly 700 Alaskans are hospitalized each year for traumatic brain injury. In addition, it is estimated that more than 3000 Alaskans visit the emergency department for a concussion or mild TBI each year. Traumatic brain injury is very expensive financially and socially. The Alaska Trauma Registry reports an average of \$16.7 million per year in hospitalization costs alone. One case reported a \$1,010,000 hospital bill. The annual average costs of \$16.7 million does not include transport costs to or from hospital, post-hospital care or therapy, transport costs to post-hospitalization care, loss of wages for patient, loss of wages for non-professional caregiver.

Research shows Alaskans who sustain traumatic brain injuries are at risk of unemployment, divorce, homelessness, suicide, substance abuse, mental health conditions, and unlawful behavior. With proper identification, diagnosis, treatment and supports, these risks can be minimized. Most importantly, many traumatic brain injuries and concussions can be prevented.

Historically there has not been a statewide awareness campaign for traumatic brain injury focusing on prevention strategies and resources. The only cure for traumatic brain injury is prevention, and once someone receives a TBI it is imperative that they are aware of the resources that will improve their recovery and life after brain injury. This awareness campaign will be instrumental in educating Alaskans statewide to the seriousness of TBI, so they understand the importance of preventing it, thus reducing the financial costs associated with this public health "silent epidemic."

Over the past 10 years, the TBI Advisory Board has heard overwhelming testimony for the need for more brain injury awareness. These communities include Barrow, Kotzebue, Nome, Bethel, Atnautluak, Fairbanks, Nome, Copper Center, Valdez, Palmer, Wasilla, Talkeetna, Trapper Creek, Healy, Anchorage, Girdwood, Seward, Kenai, Kasilof, Soldotna, Homer, Cordova, Juneau, Ketchikan, Prince of Whales, Sitka, and more). This project is supported by the Alaska Native Tribal Health Consortium Injury Prevention program, as well as the six active head injury support groups across the state (Ketchikan, Juneau, Anchorage, Mat-Su, Homer, and Fairbanks).

Project timeline is 5 years- an estimated \$40.0 will be utilized each year to support this initiative
