Detailed Project Description and Justification:

The City of Kasaan requested \$281,900 for FY2012 and did not recieve it, so we are phasing out the request. Phase one of the remodel and upgrade of the David S. Peele Community Hall would include fixing the wiring, replace and repair the heating system, replace the windows and replace the appliances in the kitchen.

The building was constructed in the 70's and in the late 80's a apartment for the VPSO, larger city office space and a larger clinic were added on.

The wiring is not adaquate for functions that take place here or for all the computer office equipment.

We would like to replace the furnace, insulate the floor and repair the heating ducts under the building. The newer rear offices are always cold and require an electric heater to keep them warm. The windows are old wooden ones that need to be replaced for energy efficiancy, as a lot of heat is lost due to drafts.

The refridgerator and stove are over 35 years old and need to be updated for energy efficiancy.

WHEREAS, the Organized Village of Kasaan (hereinafter "OVK") is governed by a Council of elected representatives composed of a President and six members who act in accordance with the powers granted to it by its Constitution and By-Laws (Ratified on October 15, 1938); and

WHEREAS, the OVK fully supports the City of Kasaan's Resolution, No. 12-023, adopting a prioritization of projects list for Capital Improvements in our City; and

WHEREAS, the OVK would like to add to the list of projects for Capital Improvements to include "Recycling Center" improvements to the list; and
