Due to the increase in freight and material costs, current funding is not adequate to finish the project. The Project is necessary to provide a building that meets the needs of all who seek health services. The City of Wales would like to ensure all the necessary repairs are completed in order to provide a fully operational and functioning clinic.

The building has suffered extensive structural damage, needs electrical upgrades, and has other related problems. The septic system has also been condemned. The health services provided by this facility is more than enough to justify the project.

Project Timeline:

The Denali Commission and ANTHC have helped the City of Wales by providing assistance. After funding is secured, the reconstruction is to commence as soon as possible.

The Wales Clinic scope of work and budget appropriations are as follows: The Structural, Electrical, and Mechanical problems will be addressed during the project. The land issues of the 14(c) conveyance has complicated the issue; but ANTHC has been very helpful in this area. The City of Wales will then by easement gain control of the land, which is the site used by the Wales Clinic.

In addition, the 40' Draw Trailer will be used to transport various construction materials to Wales for the project; this will eliminating extra cost for hauling materials. The money saved can be used to further repair our clinic structure.

The Wales Clinic has a budget of \$402,000 at present:

\$120,000 is for Plans and design of corrective measures to address the building defects.
