Detailed Project Description and Justification:

Soldotna Unit: Housed in Redoubt Elementary School at 486 West Redoubt, Soldotna AK 99669

Current Membership total is 528. Average Daily Attendance is 45.

Programming Highlights: Boys & Girls Club programming including education and career programs, character and leadership, health and life skills, arts and crafts, sports, fitness and recreation, and other specialized programs. We provide a safe, fun, and positive place for kids every day after school as well as all day during the summer months.

With a growing membership and limited recreation space available to afterschool programs, Boys & Girls Clubs of the Kenai Peninsula, in partnership with Redoubt Elementary School and school district, will plan, permit and acquire a portable for afterschool programming. The additional space will accommodate more youth, a much needed community benefit as the Clubhouse has a waitlist of 50 children. The designated space will also provide member access to computers during homework hours, and equipment and programs designed for high-yield learning. The principal at Redoubt Elementary fully endorses this project and has pledged support and partnership throughout the process.



Jessica had been on a waiting list of approximately 50 students for several months. Our excitement grew as she slowly worked her way up the list. Before the Boys & Girls Club her only option for after school care was her former Daycare which consisted of limited staff and kids that were not of school age. Even in the short amount of time that my daughter has been enrolled in the B&G after school program Jessica's teacher along with myself, have noticed an exciting change in Jessie. She has become more involved and more interactive socially. I can credit that to the excellent staff of volunteers and the great variety of programs from sports to study programs to exciting games for these after school children to participate in. Just last month Jessica was named Youth of the Month in her program, this was a huge confidence builder for her. It also proved to us what a fantastic staff and program that the Boys & Girls Club provides for our children. Unfortunately the only limitations that this program has is providing more staff and space to accommodate the numerous kids who need after school care that are still on a waiting list. More facility space would be a great asset to the club and to the community, but most of all to the children.

Thank you for the opportunity to apply for a grant which would allow the Boys & Girls Clubs of the Kenai Peninsula to place a portable clubhouse room at Redoubt Elementary. The Soldotna Club has been housed in Redoubt Elementary School for about 14 years, first as part of the After The Bell program, and then as a Boys & Girls Club. We are very grateful for the use of Redoubt for our Afterschool and Summer Programs. However, due to little available classroom space, the Club is unable to accommodate all the requests from area families who need our services.

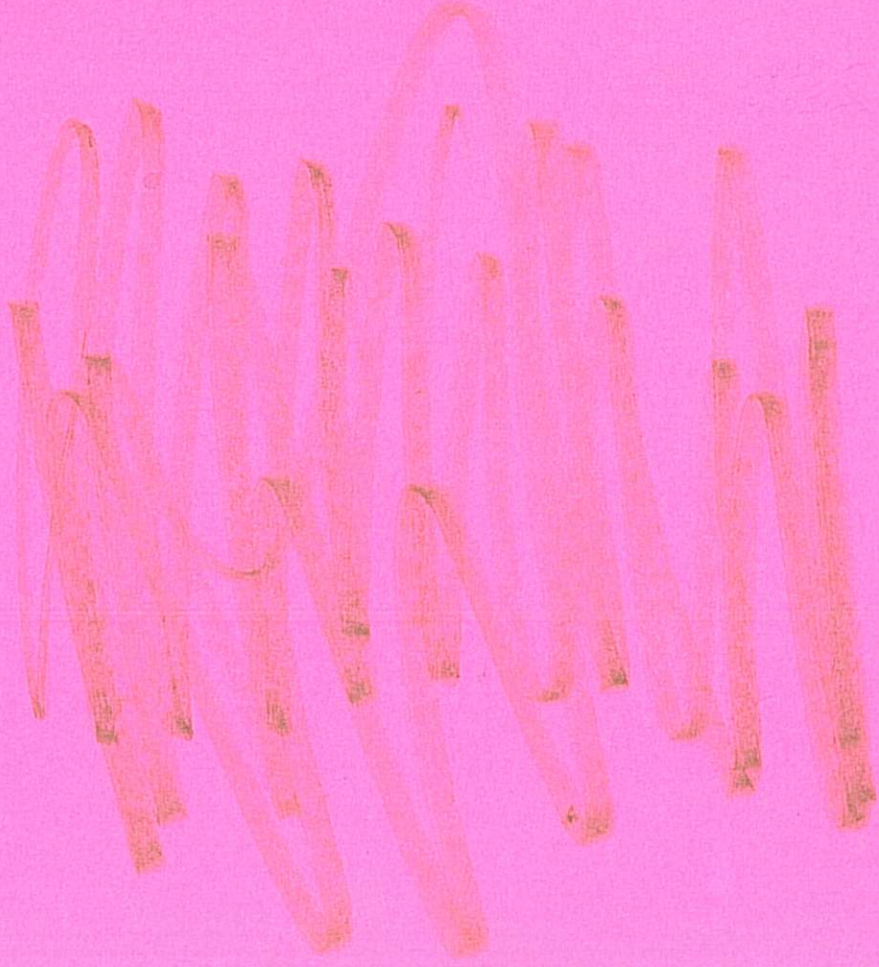
When I became the Soldotna Club Director seven years ago, the Club already had a wait list. Since then the list has continued to grow despite every effort to accommodate as many children as possible. At one point we had 90 youngsters waiting, but since then the list has hovered between 50 and 60 names most of the time.

To give you an example of the difference one portable classroom could make - between 2009 and 2011 we averaged 195 club members per year. In 2008, the one year the Principal was able to give us our very own classroom for ten months (September – July), we served 260 youngsters.

Therefore, we respectfully request that you support our grant request.

My wife and I work fulltime and cannot afford to send our kids to daycare for two and half hours 5 days a week.
