Detailed Project Description and Justification:

The number of women who need help negotiating difficult circumstances that surround pregnancy and parenting continues to grow and the demand for the Crisis Pregnancy Center's services continues to grow with it. It is our desire to relocate to a different facility to better serve women who need help that is normally supplied by a stable support network of family and friends. CPC has been offering this support for 27 years in Anchorage and in a variety of communities around the state of Alaska, including many rural communities. CPC offers education and support services in many remote access communities. Our goal is to reduce our long term operating costs so that we can increase the quality and scope of our services and reduce the cost to the community by securing a permanent location with a substantial equity position. CPC offers pregnancy tests, sonograms, STD testing, resource networking, counseling, parenting education paired with a baby cache filled with all the supplies necessary for healthy child rearing all free of charge and at no cost to the city or state. CPC has been active throughout Anchorage School District and various other school districts in the state by providing responsible sex education through its Let's Talk program. The capital funds will be used to acquire approximately 6000 square feet of office space in an easy to find and easily accessible location. CPC has a wide base of public support from individual donors, local businesses, and local churches from which we aim to raise the additional \$630,000 that we will need to complete this project.

The goal is to have all funds raised by December 31, 2012 and to acquire property/building within the first quarter of 2013.
