Boys & Girls Clubs of Southcentral Alaska will facilitate the remodel of its anchor Clubhouse in West Anchorage which houses licensed child care and athletics programs for families city-wide, as well as an afterschool program for Spenard/Turnagain children and teens.

Boys & Girls Clubs is a private non-profit corporation in its 45th year of service to Alaskan youth. Boys & Girls Clubs is affiliated with the national organization Boys & Girls Clubs of America and share their commitment to help youth of all backgrounds develop the qualities needed to become responsible citizens and leaders. Boys & Girls Clubs' mission is to empower and inspire the diverse youth of Alaska to realize their full potential by offering them hope, opportunity, and a safe environment in which to grow.

Forty-two Clubs serve over 12,000 young Alaskans each year, and Clubs welcome thousands of visiting families and youth at our community events and Clubhouse activities. Each day, Boys & Girls Clubs help our state's youth by:

- oMentoring children during the peak juvenile crime hours of 3:00 to 6:00 p.m.;

oUtilizing over 200 professionally-trained youth development staff and enriching our programs with 450 community-minded volunteers;

oProviding a safe, supervised environment for young people during vulnerable hours; and

oAddressing key issues such as violence prevention, healthy lifestyles and school and work readiness through outcome-based curricula.

Impact on Community and Members:

This project addresses upgrades of the Woodland Park Campus -- housed in an aging school building and serving youth from throughout the metro area in year-round licensed childcare and athletics programs, and Clubhouse activities (after school programs and summer programs).

Needs include:

- Purchase and installation of roof top HVAC units to replace a 50 year old boiler -- which is far beyond its estimated useful life,
- Development of new and refurbishment of existing childcare service areas,
- Replacement of worn playground, utilized by not only by Boys & Girls Club kids -- but also by children that reside in the community. The new playground will include separate, age appropriate play areas for toddlers, young children and older youth.
- Infrastructure upgrades, primarily technology

The building has been steadily renovated over the years and serves the community well.

- Sprinklers are currently being installed in the 40,000 square foot building (Completion expected Spring 2012)
- A completely new commercial kitchen was installed about three years ago. Children in licensed childcare are served hot and nutritious meals and snacks. A partnership with Children's Meal Mission ensures community children are able to enjoy a hot dinner every afternoon.
- Gym and dojo areas serve as excellent active areas for youth.
- Carpet and tile has been replaced in seven childcare rooms and the large communal Clubhouse area funded through materials grants provided by two donors. There remains enough flooring product to continue replacing old and worn flooring in most of the remainder of the building. Flooring installation has been provided through in kind services.

NARRATIVE BY RENOVATION PROJECT/BUSINESS UNIT

Rooftop HVAC Units x 5 = \$370,000:

About half of the Woodland Park building has been converted to heating and air conditioning via roof top units. This request would cover the roof top units that would completely replace the 50-year-old boiler that is far beyond its estimated useful life.

If we encountered a boiler failure --the building would be shut down and unable to serve children until units could be ordered, shipped and installed leaving many youth and families without this important community resource.

Childcare is in extremely short supply in the Anchorage area, as it is across the state. Currently, the Woodland Park Boys & Girls Club Licensed Childcare (serving ages 6 weeks -- 12 years) serves about 192 youth. Existing furnishings are old and battered. This request would replace all existing childcare classrooms with commercial grade, high quality furnishings designed especially to meet the needs of children and encourage healthy and active pursuits in the childcare setting. Additionally, this grant would allow us to expand the childcare center adding services for an additional 40 -- 45 youth.

Outdoor play is an important part of growing up healthy. Currently, Clubhouse, Childcare, and Athletics participants as well as the neighborhood youth use the playgrounds at the Woodland Park Campus. This grant would allow for upgrades for a toddler and preschool playground with safety fencing and age appropriate, commercial grade play items. The school age playground would be completely redesigned -- eliminating the first generation play equipment left from when the school opened 50 some years ago.

We have two partners for the playground project that will assist in planning and design (provided in-kind).

First Aid Training Equipment is needed at the Woodland Park Clubhouse Operations office for training Boys & Girls Club staff and volunteers. Over 50 staff are trained and certified annually as an additional safeguard for protection and safety of the youth we serve. CPR & First Aid Certification is also a licensing requirement for staff in our Child Development Center. The latest technology and equipment is needed to ensure training is up to date and effective.
