*Funding Details:**The current fire truck was purchased in 1976 and there has been no funding source for upgrades to the fire truck or equipment since.***Detailed Project Description and Justification:**

The City of Fort Yukon would like to purchase a new fire truck that is reliable, easy to service, have current parts available, with more water capacity. Currently we run into problems at fire locations with the fire hydrants being so far apart that by the time we get the hoses strung out we run out of water in the truck. Our fire truck is 35 years old and we have to warm the engine a certain amount of time before the truck will move and its kept in a warm garage. We respond to a total of 20 or more house and brush fires in a year. At this time it is of extreme urgency that we have a new fire truck in place for the safety and welfare of the residents of the community of Fort Yukon.

If the funding becomes available by July 1 2012 we can purchase it by the end of July and have it on the last barge in September


A RESOLUTION REQUESTING THE STATE OF ALASKA LEGISLATION TO

WHEREAS, the City of Fort Yukon submits the #1 prioritized project as the "New Fire Truck" as a Municipal Capital Improvement Project, and;


