The South High School Athletic Field Improvements Project has been in process since shortly after the high school opened in the 2004/2005 school year. South High students were unable to use the athletic field at all the first year due to ASD attempt to grow grass on the field. The following school years proved to be completely impossible to create safe field conditions, which caused many injuries to student athletes. During wet spring/summer seasons, the field was complete mud and standing water. During the one dry spring/summer season, the field was completely hard packed dirt and rocks. Between 2004 and 2008, multiple high schools and middle schools in the Anchorage School District had artificial turf installed on their athletic fields (Chugiak High, Dimond High, Eagle River High, Begich Middle, Clark Middle), and as a result saw far fewer student athlete injuries. Chugiak and Dimond High completed artificial turf installation and other field amenities with legislative capital grant funding. Their fields are now safe for student athletes, and they are able to host varsity sporting events at their schools. South High School thanks the legislature for the two initial grants for field improvements, and would now like to complete its athletic field improvements project to promote equality among high schools for hosting varsity events and to provide an athletic facility for use by the community.

Project Timeline:

Design, permitting, and turf installation has occurred. Upon confirmation of FY2013 funding request, the remaining field improvements projects would go out to bid in January or February 2013, depending on Anchorage School District, and construction would occur in spring and summer of 2013.

It is time once again to ask for your continued support with appropriating legislative capital grant funds to complete the South Anchorage High School multi-use athletic field improvements project.

As you know, we have been asking for legislative support for this field improvements project since South High opened in the 2004/2005 school year. Thanks to your support, South High received partial project funding on two previous occasions (FY2008 grant of \$500,000 for initial design, permitting, and start-up construction; and FY2011 grant of \$1,354,000 for artificial turf and protective fencing installation). This means that the first two out of three project phases are complete.


While South High now has a safe field surface, the ultimate goal of having a completed multi-use athletic field facility capable of hosting varsity events remains just out of reach. South High principal Kersten Johnson and the Anchorage School District have submitted a legislative grant request for completion of this project. Please support what we hope will be the final request to complete this long-awaited project.

We urge your support because we believe this project is very important to all Southside elementary and middle school youth, South High School youth, and the community at large. As you know, Chugiak and Dimond High School multi-use athletic facilities have greatly enriched the lives of their students and brought their communities together. We wish to provide that same sense of community on the Southside of town.

In addition to the obvious benefits to youth and the community at large, completing this project will allow South High to host varsity events at the school. What this means to concerned parents is the need for their children to travel to Chugiak and Dimond to attend and support South High's Varsity sporting events against all other high schools will be greatly minimized. The completed facility will also generate funds in gate receipts and rentals for the Anchorage School District. Those funds can be used to cover maintenance and other costs the ASD typically requests to be funded through legislative grants and municipal bonds. It is our belief that, if managed properly, ASD-owned multi-use athletic field facilities will allow ASD to generate much-needed funds to support its students. This is a much better alternative than spending money to lease non-ASD facilities.

Thank you in advance for supporting funding of this third and final phase of the project with what we hope will be the final legislative capital grant appropriation. We trust you agree it makes sense to finish what has been started at South High. On behalf of past, present, and future South area youth, families, student athletes, and the Anchorage community that will benefit from this project, thank you for your support and consideration.
