### **Brief Project Description:**

Purchase and install new burn box at the existing Atagan landfill to replace existing failing unit.

### **Detailed Project Description and Justification:**

This project will be to purchase and place into service an air curtain burn box to replace the existing burn box in the Ataqan Landfill that was put into service in 2004 with an induced draft combustion. The existing installation has served its useful life and provided significant reduction in waste on Saint Paul. The deteriorated condition of the exiting burn box is now generating some Community complaints to ADEC. The new burn box will incorporate operational issues found in the construction and operation of the existing installation.

Confined burning of solid waste on Saint Paul has significantly reduced the solid waste volume placed in the landfill cell and reduced possible desease vectors and attractants for wildlife. As a rat-free island with significant interest in bird and seal viewing, maintaining this condition is of paramount importance to the Community.

#### **Project Timeline:**

Final design and equipment selection will be conducted in the month following grant approval. Shipment of equipment and sitework will be completed in the late fall of 2012. Equipment will be installed into service during the early winter of 2012.
