Brief Project Description:

On-Base public transportation continues to be a challenge for our service members and their families. In Alaska, the Armed Services YMCA (ASYMCA) has been able to fill this gap by offering a \$1.00 "door to door" shuttle service on our State's three largest military installations.

The shuttle service, offered on Joint Base Elmendorf Richardson and Fort Wainwright, is available to all Active Duty, Reserves, National Guard, retirees, and their family members from all branches of service.

Funding Details:

State of Alaska provided a \$50,000 grant for fuel and maintenance in 2006. Municipality of Anchorage provided a \$15,000 grant in December 2010.

Detailed Project Description and Justification:

We provide young military members and their families, who are without reliable transportation, access to the various services and recreational opportunities on base as well as connectivity to the local public transportation systems. We have extended this service to civilian employees working on the military installations by making routine pick-ups at the mass transit bus stops immediately outside the Base and Post gates. In essence, we have become an extended arm of the city and state transportation services.

Originally, the program was offered free of charge to service members and their families; however, with the rising cost of fuel and lack of dedicated program sponsor, we began charging a modest \$1 per ride to help recover a portion of the program's expense. This decision was made with great heartache but out of necessity to keep our most expensive program operating and available to our troops who need it most. We do not want any service member, family member, veteran or retiree to forego trips to medical facilities, the grocery store, or other important errands because it is too cold or far to walk and they lack access to other reliable transportation.

Below are some of the key points of this program:

- Service is offered on Joint Base Elmendorf Richardson (JBER) and Fort Wainwright. There are more than 53,000 active duty personnel and their families stationed at these bases. Additionally, there are another 13,000 service members and family members stationed in outlying areas that rely on JBER and Fort Wainwright for logistical support (medical/shopping/etc) who often utilize the shuttle. The 66,000 total does not include retirees, veterans, and civilian employees who have access to the shuttle service.
- This statewide program has been operating for 5 years and serves more than 40,000 riders a year. More than 25% of the riders are active duty junior enlisted service members (E1-E5).
- Our drivers log 400 miles per day, with the lion share of these miles going to and from military housing/barracks and high-traffic areas like the Base Exchange and hospital.
- Our vehicles spend 95% of these miles on the main base arteries and high traffic areas providing excellent exposure for a potential sponsor.
- Security restrictions as well as fiscal constraints make it impractical for the local public transportation systems to serve the on-base populations. Additionally, a typical Taxi fare from the barracks to the Military Mall is \$35.00 one way, not to mention the long wait to procure service, as base access is restricted to a select few taxi drivers.
- Military shuttles are near extinct due to budget cuts. Additionally, military regulations severely restrict the use of Defense assets from providing [door-to-door] service. If there is a military shuttle on the installation it has limited hours, a specific timed route, and for duty purposes only, which means trips to the hospital and commissary are not authorized nor are family members, veterans or retirees allowed to use the service.
- As a feeder service for the Anchorage People Mover, we help open access for civilians to on-base employment.
- We are often the only means, other than walking, for VA and retirees to access the on-base hospitals and pharmacies.

Goals:

- 1.To ensure that service members and their families have access to all of the facilities onboard these military installations.
- 2.To avoid long-term exposure to Alaska's inclement weather; thereby, reducing injuries due to falls, exposure to extreme cold, etc.

Outcomes:

- 1. Service members can take full advantage of programs or services offered at the military installation.
- 2.No injuries occur due to falls or exposure to extreme weather.

Although we only charge \$1.00 for our riders, there is a greater expense incurred by the ASYMCA. The transportation program costs \$4.25 per rider or approximately \$210,410 a year. Outside of program sponsorship and the \$1 fee, the rest of the cost will be met through donations and local support.

Project Timeline:

Y on Wheels shuttle operates Mon-Fri year round. Expenses such as labor and fuel are incurred daily, where as routine maintenance occurs monthly. Depending on wear and tear, more extensive repairs require prompt maintenance and are not predictable.

Organizational History

The Armed Services YMCA (ASYMCA), a non-profit 501(c)3 organization, is a national member association of the YMCA of the USA and works with the Department of Defense.
