Boys & Girls Clubs is a private non-profit corporation in its 45th year of service to Alaskan youth. Boys & Girls Clubs is affiliated with the national organization Boys & Girls Clubs of America and share their commitment to help youth of all backgrounds develop the qualities needed to become responsible citizens and leaders. Boys & Girls Clubs' mission is to empower and inspire the diverse youth of Alaska to realize their full potential by offering them hope, opportunity, and a safe environment in which to grow.

Forty-two Clubs serve over 12,000 young Alaskans each year, and Clubs welcome thousands of visiting families and youth at our community events and Clubhouse activities. Each day, Boys & Girls Clubs help our state's youth by:

- oMentoring children during the peak juvenile crime hours of 3:00 to 6:00 p.m.;
- oUtilizing over 200 professionally-trained youth development staff and enriching our programs with 450 community-minded volunteers;
- oProviding a safe, supervised environment for young people during vulnerable hours; and
- oAddressing key issues such as violence prevention, healthy lifestyles and school and work readiness through outcome-based curricula.

For the Gym:

Wall pads to both ends of the gym; pole pads on the basketball poles provide safety

Two rows Hide-a-Benches that fold up and are padded when not in use

Portable scoreboard

Two Six-shooter Youth Basketball Goals that will help in the development of our younger members

These additions to the gym will increase the safety for Club members, increase the usage and open the possibility of hosting community tournaments and games. Staff will also be able to reach out to younger members who can't play on a regulation size basketball hoop.
