Detailed Project Description and Justification:

Funds would complete the Little Steps Preschool, including two additional classrooms, an indoor gymnasium/gross motor room, and playground completion as mentioned above. This will allow Little Steps Preschool, which is a component of Denali Family Services to expand their services and allow more children into their center. Currently Little Steps is the only inclusive behavioral preschool in the state of Alaska working with 'typically developing' children and those meeting severely emotionally disturbed (SED) clinical criteria in the same classroom setting. Little Steps would be able to, with these funds, serve an additional 25 families and provide an even higher quality of care with the completion of the gymnasium, classrooms, and outdoor space. Little Steps was granted the honor of becoming a national demonstration site for the social-emotional curriculum used there and is continuing to be a model center for social emotional competence and teaching strategies turned to by other centers needing guidance.

7/1/12-8/31/12: Complete various aspects of Phase 2 of construction to include two additional classrooms, an indoor gymnasium/gross motor room, and finishing the playground area.

On behalf of **thread**, Alaska's Child Care Resource and Referral Network, I am writing you in support of your request for State of Alaska Capital funds to complete your Little Steps early childhood program playground and finalize construction of your building.

thread promotes accessible, affordable and quality early care and early learning for Alaska's children. We work to strengthen the early care and education industry by empowering parents, educating child care professionals, and collaborating with communities. Annually, we work with over 7,500 parents to assist them in their search for early care and education programs; we provide training to over 3,000 early care and education professionals to help prepare them for their work with children; and we work with community partners such as Little Steps to meet the needs of working families and their children. We have a strong and valuable partnership with Denali Family Services and Little Steps and find that they provide high quality services to some of the most vulnerable children and families in Anchorage.

However, finding quality and affordable child care in Alaska is often challenging. Currently in Anchorage, there are approximately 10,500 regulated early care and education spaces, yet that only meets half of the demand of working families.
