Detailed Project Description and Justification:

The garden plots at Bragaw/Glenn Highway have sat vacant since their construction in 2010 and add a look of blight to the Mountain View and Russian Jack neighborhoods. Residents, community organizations and multiple Community Councils have recognized these gardens as a place to improve quality of life for community members by providing ample space and opportunity for gardening needs. Increasing garden space for Alaskans has numerous benefits: it promotes healthy lifestyles; it is income-neutral; it is gender-neutral; it is an outlet for artistic expression and recreation; and, it beautifies the community.

Funds are requested for upgrades of the community garden space constructed along with the Glenn Highway and Bragaw Interchange in 2010. These plots have been non-operational, but negotiations are currently underway to put them in use for the community. Anchorage currently does not have enough gardening space for its residents. The community has asked that a Memorandum of Agreement exist between ACLT and the MOA to administer the gardens at Bragaw/Glenn and thus expand gardening opportunities. Additionally, ACLT is organizing community partners to facilitate the garden, and a volunteer--driven association will save funds for the Municipality and make for dynamic new opportunities as the interest in gardening and food security increases. Partnerships have been formed to insure that learning initiatives for local students as well as rural Alaskans will be a part of the garden programming.

Request for funding includes safety and security upgrades, garden improvements, equipment, utilities, operations and maintenance and administering and securing new spaces for advancing gardening and greening opportunities.
