**Brief Project Description:**

Improve pedestrian and bicycle facilities on Glacier Highway from Sunny Point interchange access road (Walmart) to Anka Street. Rehabilitate pavement, widen Lemon Creek Bridge, add sidewalks, lighting and improve drainage.

**Detailed Project Description and Justification:**

These funds will accelerate work on a project to improve pedestrian and bicycle facilities on Glacier Highway from Glacier Highway Access Road (at Sunny Point) to Anka Street. Improvements include adding sidewalks, modifying and improving drainage of the roadway, striping bike lanes, determining crosswalk locations, adding sidewalk on the south side of Lemon Creek Bridge, resurfacing the entire length of the roadway, installing bus pullouts at Alaway, and making necessary adjustments to intersections and driveways. The project will install highway lighting along the corridor as needed.

By accelerating this project's funding with general obligation bonds, the work can proceed more quickly, saving construction cost inflation and reducing federal permitting requirements. This acceleration and improved efficiency is expected to save significant funds from the initial estimate of \$7.3 million.
