RECOMMENDATIONS:

The House Finance Budget Subcommittee for the Alaska Court System submits a recommended operating budget for FY2012 to the House Finance Committee as follows:

BUDGET ACTION:

The House Finance Budget Subcommittee for the Alaska Court System held 3 meetings with the Department and analyzed all of the Governor's budget transactions. The following are budget action highlights:

- The Subcommittee recommends authorizing \$1048.0 less general funds and 3 less full-time positions than the Governor's Amended FY2012 request.
- The Subcommittee recommends a total increase from the FY2012
 Adjusted Base of \$3,136.9 UGF and \$0 DGF for a total General Fund
 change of \$3,136. The change from Adjusted Base in Other Funds is
 \$1,070.2 and from Federal Funds is \$0. The total change from the Adjusted
 Base is \$4207.1 and 16 full-time positions.

Accepted

1. Trial Courts-No Dark Courtrooms \$934.8 GF

The "No Dark Courtrooms Initiative" is integral to the Court System's long range plan to improve courtroom efficiencies and streamline proceedings

2. Trial Courts- Establish a District Court in Hooper Bay

Hooper Bay is the most populous community in the Fourth Judicial District without a resident judicial officer

3. Improve Handling of Cases involving Children \$276.1 UFG

Due to the complicated nature of child custody disputes, additional intervention funds were included to help families resolve their differences in a timelier manner and to conserve judicial resources.

The House Finance Budget Subcommittee for the Alaska Court System had no Governor's budget amendments submitted.
