BUDGET ACTION:

The House Finance Budget Subcommittee for the Legislature held one meeting with the agency. The Subcommittee reviewed the FY2014 budget request and took the following actions:

Accepted the Legislature's amended proposal that includes these highlights:

- Added \$100.0 in Legislative Audit for information technology training and consulting
- Consolidated nearly \$2 million of space costs from several allocations into the Facilities Rent allocation

- Expenses are reduced by \$250.0 in Legislative Finance to be split evenly between the House and Senate Committees
- Expenses are reduced by \$350.0 in Committee Expenses
- Expenses are reduced by \$25.0 for the Commission on the 100th Anniversary of the Legislature
- Transferred the Session Expenses allocation from the Legislative Council appropriation to the Legislative Operating Budget appropriation
- Transferred the Legislature State Facilities Rent allocation from the Budget and Audit appropriation to the Legislative Council appropriation

The Subcommittee took the following additional reductions:

- Expenses are reduced by \$1,000.0 in Legislative Finance to be split evenly between the House and Senate Committees
- Expenses are reduced by \$800.0 in Committee Expenses
- Expenses are reduced by \$200.0 in Council and Subcommittees

The Legislature's budget is \$2.2 million below FY2013 Management Plan and \$2,537.7 below the Governor's Amended FY2014 level.
