# DEPARTMENT OF FISH & GAME FY2015 SENATE FINANCE BUDGET SUBCOMMITTEE NARRATIVE REPORT March 17, 2014

### **RECOMMENDATIONS:**

The Senate Finance Budget Subcommittee for the Department of Fish & Game submits a recommended operating budget for FY2015 to the Senate Finance Committee as follows:

Unrestricted General Funds (UGF)	\$79,562.8
Designated General Funds (DGF)	\$ 9,017.3
Other Funds	\$62,653.0
Federal Funds	<b>\$63,713.</b> 1

TOTAL \$214,946.2

## **BUDGET ACTION:**

The Senate Finance Budget Subcommittee for the Department of Fish & Game held <u>2</u> meetings, including one joint meeting with the House Finance Subcommittee. Meetings were held with the Department and analyzed all of the Governor's budget transactions. The following are budget action <u>highlights</u>:

The Senate Budget Subcommittee recommends a reduction from the FY2015 Adjusted Base of \$1,020.0 in UGF, \$709.8 in other funds, \$39.0 in federal funds, and an increase of \$200.0 designated GF, for a total reduction of \$1568.8 in all funds.

- In the Westward Region:
  - Increased Test Fish Receipt Authority by \$200.0 for Golden & Red King Crab Research.
- \$885,000 Unallocated Reduction:
  - o Division of Sport Fisheries \$100.0
  - o Division of Commercial Fisheries \$405.0
  - o Division of Wildlife Conservation \$220.0

- o Administration & Support Division \$160.0
- Technical Adjustment to the Sport Fish Enterprise Account, moving \$500.0 from the numbers section to the Language section for Sport Fish operations.
