DEPARTMENT OF REVENUE FY15 SENATE FINANCE BUDGET SUBCOMMITTEE NARRATIVE REPORT March 10, 2014

RECOMMENDATIONS:

The Senate Finance Budget Subcommittee for the Department of Revenue submits a recommended operating budget for FY2015 to the Senate Finance Committee as follows:

Unrestricted General Funds (UGF)	\$32,198.1
Designated General Funds (DGF)	\$9,761.2
Other Funds	\$252,191.2
Federal Funds	\$77,584.4

TOTAL \$371,734.9

BUDGET ACTION:

The Senate Finance Budget Subcommittee for the Department of Revenue held 2 meetings with the Department and analyzed all of the Governor's budget transactions. The following are budget action <u>highlights</u>:

- The subcommittee recommends increasing the Permanent Fund Dividend division by 66.9 thousand in DGF for the Pick. Click. Give. Program.
- The subcommittee recommends decreasing the Permanent Fund Dividend division by <66.9> thousand in UGF for the Pick. Click. Give. Program.
- The subcommittee recommends changing 125.0 thousand from the Natural Gas Commercialization base allocation to a one time increment (OTI) for FY15.
- The subcommittee recommends increasing receipt authority by 49.9 thousand for the Mental Health Trust Authority for Mental Health Trust Administrative Receipts.
