RECOMMENDATIONS:

The House Finance Budget Subcommittee for the Department of Environmental Conservation submits a recommended operating budget for FY2016 to the House Finance Committee as follows:

The Unrestricted General Fund difference from FY15 Management Plan to the House Subcommittee budget recommendation is a reduction of \$1,787.4 which is an eight (8) percent change and a reduction of 24 PCNs.

BUDGET ACTION:

The House Finance Subcommittee on the Department of Environmental Conservation Budget held four meetings on February 5, 12, 19, and 24, 2015 with the agency. The Subcommittee reviewed the FY2016 budget request and took the following actions:

Accepted the Governor's amended proposal, which includes these highlights:

Reduction of 25 PCNs – The Governor's Endorsed budget included the reduction of the following positions:

- Office of the Commissioner 1
- Food Safety and Sanitation 8
- Laboratory Services 2
- Drinking Water 5
- Solid Waste Management 1
- Spill Prevention and Response Division 4
- Water Quality 4

Air Quality 123.0 GF/Prgm Increment 1 PCN

The Governor's budget included an increment for the Air Quality Permitting Program to meet growing oil and gas industry needs. This PCN is paid for by program fees.

Laboratory Services Fish Tissue Monitoring Program, decrement (250.0) 1004 GF

The Department of Environmental Conservation created the Fish Tissue Monitoring program in conjunction with the Departments of Health and Social Services and Fish and Game, to show that Alaska's fish are safe for subsistence, recreational, and commercial consumers. The program came into existence in response to EPA instituting a national advisory to restrict fish consumption based on their monitoring data collected outside Alaskan waters. In FY2002, Alaska instituted its own program to conduct on-going fish tissue testing which provides supporting data that enables the state to override the federal fish consumption guidelines. DEC is the lead agency for gathering, analyzing, and publishing the data that is used by corporations, State agencies, residents, and tourists. The Fish Tissue Monitoring program was initially funded by federal receipts. When federal funding for the program was lost, it was replaced with a \$557.0 general fund increment in FY2013. Since FY2013, the program has been solely funded with general funds.

Laboratory Services Fish Tissue Monitoring Program, Fund Source Change (250.0) 1004 GF and \$250.0 1205 Ocn Ranger Fees Under the authority of AS 46.03.480, an Ocean Ranger fee of \$4 per berth is imposed on all large commercial passenger vessels. Those fees are retained in a sub-account of the Commercial Passenger Vessel Environmental Compliance Fund and are designated for the "purpose of operating the Ocean Ranger Program established in AS 46.03.476." While ocean ranger fees are deposited into a fund that can be used for more expansive purposes, the fee itself is statutorily designated for the Ocean Ranger Program only and as such, the \$250.0 will remain in the Ocean Ranger Fund.

ITEMS OF INTEREST:

Legislative Intent Language:

- It is the intent of the legislature that the Department of Environmental Conservation will develop a plan to reduce the costs for the state and private entities related to oil spill response drills and exercises, and will report findings to the Finance Committees by January 19, 2016.
- It is the intent of the legislature that the Department of Environmental Conservation will develop a plan to increase cost recovery efforts for spill prevention and response, and will report findings to the Finance Committees by January 19, 2016.
