## Department of Revenue FY2016 House Finance Budget Subcommittee Narrative Report February 26, 2015

## **Recommendations:**

The House Finance Budget Subcommittee for the Department of Revenue submits a recommended operating budget for FY 2016 to the House Finance Committee as follows:

Unrestricted General Funds (UGF)	\$30,225.6
Designated General Funds (DGF)	\$10,323.4
Other Funds	\$282,452.6
<u>Federal Funds</u>	\$78,130.6
Total	\$402,132.2

### **Budget Action:**

The House Finance Budget Subcommittee for the Department Revenue held six meetings with the Department and analyzed all of the Governor's budget transactions. The following are the budget action highlights:

- Reducing spending by \$3,123.3 thousand in Unrestricted General Funds from FY16 Adjusted Base
- A reduction of 9.4% in Unrestricted General Funds from FY2016 Adjusted Base.

The Subcommittee recommends accepting all of the Governor's FY 2016 request. The following are highlights for the Governor's request:

- Overall reduces \$2,466.9 thousand in Unrestricted General Funds and removes 11 positions throughout the Department
- Increases Alaska Permanent Fund Corporation's investment positions to capitalize on investment opportunities, 4 positions - \$779.7 thousand in Permanent Fund Gross Receipts

The Subcommittee also recommends the following changes to the Department of Revenue's FY2016 request:

- In order to facilitate the consolidation of Information Services and Technology with the Department the Subcommittee
  - o Removes 2 positions <\$295.5> thousand in Unrestricted General Funds
  - o Changing funding sources from Unrestricted General Funds to Capital Improvement Project Receipts for 2 positions <\$273.9> thousand in Unrestricted General Funds
- Reduces Personal Services within the Treasury Division to slow the growth of personnel - <\$87.0> thousand in Unrestricted General Funds
