BUDGET ACTION:

It is the intent of the legislature that the budget for the University should reflect this mission; and any current functions that are not directly related to the mission should be reviewed and realigned or reallocated, as appropriate since budgetary priority to the mission will produce educated workers, engaged citizens, and future leaders for Alaska.
