## RECOMMENDATIONS:

The Senate Finance Budget Subcommittee for the Department of Labor and Workforce Development submits a recommended operating budget for FY2017 to the Senate Finance Committee as follows:

Unrestricted General Funds (UGF) \$ 23,190.2

Designated General Funds (DGF) 35,767.5

Other Funds 20,417.8

Federal Funds 85,438.1

TOTAL \$164,813.6

## **BUDGET ACTION:**

The Senate Finance Subcommittee for the Department of Labor and Workforce Development held three meetings with the Department of Labor and Workforce Development analyzed the Governor's and House budget transactions.

The Senate Sub-Committee accepted the Governors amended budget, and the changes made by House Finance, with the following adjustments;

- The Senate Sub-Committee reduces the House Labor Market Information UGF reduction by \$200.0, for a total reduction of (\$100.0) UGF.
- The Subcommittee also reduces the House Employment and Training Services-Workforce Development UGF reduction by \$300.0 for a total reduction of (\$114.3)

• The Sub-Committee also reduced the House Alaska Vocational Technical Center by \$47.0 for a total reduction of (\$46.9).

## Other Subcommittee actions

 The Subcommittee also declined to accept the House intent language regarding the Alaska Construction Academy.
