BUDGET ACTION:

The subcommittee for the Department of Military and Veterans' Affairs analyzed the Governor's budget and recommends the following changes from the Governor's amended FY18 request:

A--Deny an increment request of \$210.9 UGF to expand the Alaska State Defense Force for Rural Engagement.

B--Decrement \$176.0 of UGF from the Office of the Commissioner, personal services. There are 46 positions in the Office of the Commissioner, many of them funded with multiple fund sources (total personal services funding in the allocation is \$4.68 million).

C--Structure Change: The subcommittee recommends creating a separate appropriation for the Local Emergency Planning Committee (\$300.0 UGF)
