UNIVERSITY OF ALASKA SYSTEM FY2019 SENATE FINANCE BUDGET SUBCOMMITTEE NARRATIVE REPORT April 4, 2018

RECOMMENDATIONS:

The Senate Finance Budget Subcommittee for the University of Alaska System held <u>3</u> meetings with the Department and analyzed the Governor's amended budget. The subcommittee submits a recommended operating budget for FY2019 to the Senate Finance Committee as follows:

The financial figures are \$5,500 greater than the FY19 Governor's Amended Request (19GovAmd) and \$13,470 less than the FY19 House University of Alaska System Budget report (H1). The position figures are unchanged from FY19 House Finance University of Alaska System Budget report (H1) the FY19 Governor's Amended Request (19GovAmd). The subcommittee recommends adoption of the University of Alaska System's amended budget as presented above.

In terms of unrestricted general funds, the Senate Finance University of Alaska System Budget Subcommittee version of next year's FY19 budget (SenateSub) is \$5,500 more than the current

one (Fiscal Year 2019 Adjusted Base), but this increase is in one-time funding. Under the FY19 Senate Finance University of Alaska System Budget Subcommittee plan, the agency's budget will have shrunk over five years from \$370,559.7 in UGF under the FY 2015 Management Plan to \$322,533.5 in FY 2019, a decrease of \$48,026.2 in UGF. This amount is a 12.9 percent reduction.

Under the FY19 Senate Finance University of Alaska System Budget Subcommittee plan, the number of authorized positions will have dropped over five years by 752 – from 4,934 under the FY 2015 Management Plan to 4,182 for FY19 – a decrease of 15.2 percent.

In addition, the Subcommittee has adopted three pieces of intent language contained in the attached reports related to:

- Maximizing the strength of each campus and overall efficiency;
- Efficient use of labor resources:
- Maintaining the System's position as a leader in Arctic Research and contributing to Alaska's economic development.
