BUDGET ACTION:

The Senate Finance Budget Subcommittee for the Department of Fish and Game held two public meetings and numerous conversations with the Department and analyzed all the Governor's budget transactions. Following are budget highlights.

- Governor's Amended Budget Request:
 - Accepted the Governor's Amended Budget Request
- Sub-Committee Additions, Reductions and Changes:
 - A \$138.3 I/A Rcpts decrement in the Commissioner's Office for the Communications Manager (11-7009) position which was proposed to be transferred from Statewide Fisheries Management.

Other Changes:

- O Salary Adjustment figures are informational only. It is the best guess at this time for what will likely be needed once contracts are finalized. The correct dollars will be added after close-out in the full Finance committee CS.
- O Delete the following intent language: At the discretion of the Office of Management and Budget, funding may be transferred between all appropriations in the Department.

Organizational Changes

- O The reduction of \$138.3 in the Commissioner's Office will result in the reduction of one Permanent Full Time position.
- Intent Language
 - o There was no intent language adopted.
